



WAIVER / RELEASE OF LIABILITY



READ BEFORE SIGNING - COMPLETE AND TURN IN PRIOR TO FIRST GAME

In consideration of being allowed to participate in any way in THE COURTS LLC athletic/sports program, related events, and activities, the undersigned acknowledges, appreciates, and agrees that:

1. The risk of injury from the activities involved is significant, including potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce the risk, the risk of serious injury does exist; and,
2. I KNOWLINLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others and assumes all full responsibility for my participation; and,
3. I willingly agree and comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
4. I, for myself, and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS THE COURTS LLC, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, if applicable, owners and lessors of premises used to conduct the event ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

The undersigned does hereby authorize Action Packed Sports Video & The Courts LLC and those acting pursuant to their authority, to: A – Record on videotape, audiotape, film, photograph and other mediums, both images and sounds, my participation or appearance, and that of my minor children, at sporting events which take place at the premises of The Courts. B – Use my name, likeness, and voice, as well as that of my minor children, in connection with these recordings. C – Exhibit or distribute the recordings for promotion of the business activities of the Courts and to sell, and offer to sell, the Recordings to participants and their family members. D – I hereby release and discharge Action Packed and the Company, their successors and assigns, their officers, employees, and agents, from any and all claims and demands arising out of or in connection with the use of such Recordings, including, but not limited to, any claims for defamation or invasion of privacy.
